### LINK NEWS

Diary Date 17 and 18 November - LINK Members' Congress will be on 17 November followed by the strategic planning meeting on 18 November. The venue is Birnam, Perthshire, a combination of the Birnam Institute (Thursday) and the Birnam Hotel (accommodation and Friday). The theme is sustainable development; and will build on the outcomes of the seminar on environmental economics on 30 August. The international dimensions include the Earth Summit in June 2012 – Jonny Hughes in his role on the SSDF is helping to instigate action in Scotland; and the IUCN seeks views in determining its future priorities globally. Speakers invited include Hans Friederich, Director of IUCN in Europe, John Swinney (on what Scotland might bring to the Earth Summit) and Iain MacWhirter (Carnegie report Beyond GDP round table). Congress will continue the tradition of progressing useful work of overarching relevance, excellent networking for members and invited guests, and enjoyable socialising. More information will be circulated from Alice in August. Meanwhile please note the date and tell your colleagues, especially any of them new to the network.

**LINK's new Parliamentary Office Administrator** – A big welcome to Rea Cris, starting this week in LINK's parliamentary office. Rea has a very good background in organisation, planning, and events coordination. She has interesting and varied experience, most recently with NHS Education Scotland, since qualifying in the arts (BA, MSc) five years ago, and is a volunteer with Transition Edinburgh South. LINK Board updates – Board meeting 28 June reviewed LINK's financial situation and will contact members about latest thinking later this summer. Progress with the pilot of Organisational Supporter status was assessed, the Board decided to continue this with a view to encouraging like-minded organisations (not corporates and not ones which would be eligible for membership) to sign up. Scope to extend a similar package to the commercial sector was considered though the Board concluded our approach with the private sector should continue to be on the basis of one-off corporate sponsorship, where appropriate. Also on the agenda was succession planning ahead of the AGM on 30 August; likely skills needs on the Board in coming years were assessed and members will shortly be invited to nominate. The President search continues, with replies from various of our 'A' list still awaited. The Board commented on plans for LINK's strategic review for which surveys will go out in August.

**CNPA** Recent Boards-level discussion between LINK and CNPA noted the value of LINK's strong environmental voice in Park policy discussions esp. in relation to sustainable land use, sustainable



tourism and recreation. CNPA will provide information on further forums where LINK may want to nominate a delegate and LINK staff will contact members about these. The Park's approach to sustainable development was discussed and we agreed to find opportunities for CNPA, LINK and others to consider what 'sustainable economic growth' vs 'sustainable economic development' means for 'big picture' policy development. LINK has agreed to facilitate a meeting of interested members with CNPA in September/October during the consultation period on the Park's Draft Plan and Local Plan. Since the meeting, members proposed at our June Networking that LINK facilitate a discussion, sooner, among NGOs involved in Cairngorms issues, and staff will contact members soon to propose a meeting in late summer. Please contact Kate if your organisation wants more information on either of these meetings at this stage.

**Scottish Government** - Staff recently met with LINK's Scottish Government contact, Gareth Heavisides, for an introductory discussion and to reiterate LINK's case for continued <u>ministerial</u> <u>liaison</u>; we were given the impression that continuation of at least a similar arrangement, is likely, with details to follow over the summer.

**LINK's Agriculture TF convenor**, Katrina Marsden of RSPB, has been seconded to the Scottish Parliament for the 18 months, to cover the Rural Affairs brief for SPICe. Jonathan Wordsworth of Archaeology Scotland will be taking on temporary convenor duties whilst the TF looks for a new convenor. Many thanks to Katrina for all her hard work on behalf of the Agricultural TF and we wish her all the best in her new role.

LINK Members **SCNP** and **APRS** have published a paper which sets out the benefits that more National Parks would bring to Scotland. The <u>Benefits of National Parks</u> paper forms part of a three-year joint SCNP/APRS project to promote a National Parks Strategy for Scotland. The aim of the project is to promote a strategy for developing a comprehensive network of National Parks across Scotland. The aspiration is that this could result in at least three new National Parks being designated by 2015, including Scotland's first coastal and marine National Park. ### **OTHER NEWS**

#### Better environmental regulation: SEPA's change proposals

SEPA has published the <u>results of the consultation</u> on its proposed changes to improve, simplify and better integrate the environmental protection and improvement services it provides for Scotland. There was a high level of support for the main principles in the consultation, particularly in relation to: reducing the complexity and improving the effectiveness of environmental regulation; simplifying permits (including working up proposals for single site, operator or network licences); placing an assessment of risk to the environment, and the performance of operators, at the centre of SEPA's approach; targeting environmental 'harms' and working with partner organisations and local communities to solve these; dealing with non-compliance through stronger and swifter forms of enforcement, where necessary.

<u>Scotland's Natural Capital Asset Index</u> - aims to assess the sustainability of Scotland's economic growth over coming years.

### Project partners sought for EU-wide adaptation initiative.

Oxford University is seeking project partners from regional and sub-regional local authorities/municipalities from within the European Union, to work on a bid for a project that will explore: embedding climate issues (including adaptation) within a policy context; and awareness raising / communication of climate change issues within the authority and beyond. If successful, the project would be co-financed at a maximum rate of 50% of eligible costs, so some additional funding will need to be found by participating organisations. Fellows receive a travel grant to cover return and internal travelling, daily living and insurance within the countries visited.

#### Reforesting Scotland launches Campaign for a Thousand Huts

The campaign aims to celebrate, expand, protect and enjoy the use of huts in Scotland for living, working and relaxing in. In particular it wants to raise awareness of the simple beauty and value of huts; promote sustainable hut building from local timber; and develop a campaign for huts, heart and planning changes.



Scottish Rural Property and Business Association (SRPBA) becomes Scottish Land and Estates - at the SRPBA's AGM the membership voted for changes in the operation of the organisation. The new Scottish Land and Estates body says it aims to make the public benefits of landownership more visible; raise awareness of the role of landowners and estates and promote the role estates play in their communities. They also plan to establish a new Centre for Land Policy.

<u>Scottish Power Green Energy Trust</u> - The Scottish Power Green Energy Trust supports non-profit organisations and charities to develop renewable energy. Grants of up to £25,000 are available. and applications for the current round would need to be submitted by August 15th, 2011

**Big Lottery Funding for Community Spaces** - Lottery funding of £9m has been made available to create community spaces across Scotland. Groups can apply for grants between £10,000 and £250,000, although the average grant size is expected to be about £100,000. Examples include providing facilities for community activity through developing and improving: local parks; community paths and gardens; play parks; allotments; community centres, and village halls

<u>Sustainable Eigq</u> – short film from the Open University about developing the community-owned Isle of Eigg as a resilient, self-sustaining and green island.

**Who Owns Scotland** – subscription website providing data on who owns Scotland together with maps showing boundaries of landholdings.

**Norton Park Centre Edinburgh** – offers office accommodation for the voluntary sector in Edinburgh, plus meeting rooms, interview rooms and a conference suite.

# MEPs vote against 30% carbon emission reduction

# <u>European Commission - Proposal for Directive on Energy Efficiency</u>

The European Commission's Directorate-General for Energy has published a legislative proposal for a new Directive on Energy Efficiency whichaims to contribute to the realisation of the EU's Energy Efficiency Plan to 2020 and to the achievement of the indicative target for 20% energy efficiency by 2020. Currently, the EU is on track to meet only around half of this target. Measures put forward include:

- A requirement on Member States to establish energy savings schemes, which can include obligations on energy distribution or retail companies to make efficiency gains.
- Mandatory energy audits for large companies.
- An obligation on Member States to adopt national heating and cooling plans and to adopt authorisation criteria to ensure installations are located near to heat demand points, as



- well as ensuring new or refurbished installations are fitted with high efficiency combined heat and power units.
- Requirements on the public sector to purchase energy efficient buildings, products and services; and to refurbish 3% of their own premises annually to improve energy performance.
- Requirements on energy companies in metering and billing consumers.

# Climate policy

EU Environment Ministers failed to endorse the European Commission's March 2011 Communication setting out a "Roadmap for moving to a competitive low carbon economy in 2050" at their 21 June Council meeting. Formal adoption of the Roadmap was blocked by Poland, in opposition to the emission reduction targets put forward by the Commission. The Roadmap sets out measures towards achieving domestic EU emissions reductions of 80% by mid-century, which has been agreed by EU Governments. However, the Roadmap also outlines a trajectory with interim emission reduction milestones of 25% by 2020; 40% by 2030; and 60% by 2040. The Polish Government opposed in particular the inclusion of the suggested 25% cut by the end of this decade. The EU is currently committed to a 20% reduction for 2020, with an offer to raise this to 30% if other international countries make comparable commitments.

The Council will revisit the Roadmap after the Polish Presidency of the EU (which covers the six months from July to December 2011) with the intention of adopting formal conclusions before March 2012.
