The programme will include presentations about experiences of each country and the workshops suggested to date include flooding, biodiversity, charities, marine, and possibly behaviour change and election work. LINK is on the Scottish Legacy Board for the 2012 and 2014 Games

LINK Board members Dan Barlow and Ian McCall attended the first meeting on 25 April. The Chair of the Board, Pam Whittle, Director of Public Health and Wellbeing in the Scottish Government, agreed that, given the breadth of interest and experience within LINK, both Dan and Ian should continue to represent LINK at future meetings. The Legacy Board will focus in five sub groups on how the games can help achieve the Government's five strategic objectives. The Greener sub-group will take forward the work of the 2014 Environmental Forum in which a number of LINK bodies have already been involved. The main areas of interest in the legacy for LINK organisations are likely to include:

- The Games' ecological footprint
- Setting new standards in design, energy use, waste etc
- Promotion of greenspace, habitat improvements and development of path networks
- The legacy of enhanced physical activity from the Games

LINK gave a response to the consultation on the legacy in May.

Report on IUCN by Mark Huxham, LINK Representative

There were three main activities of relevance to LINK undertaken in the last year by the IUCN UK executive committee:

1. Who pays for biodiversity?

The final report will shortly be available on the **IUCN UK website**. The objectives were:

- To estimate the financial outlays from UK public and private entities contributing towards the 2010 target.
- To set actual expenditure in the context of the estimated costs of achieving the 2010 target and of the benefits associated with the conservation of habitats and maintenance of ecosystem services.
- To build on current national and EC initiatives for measuring biodiversity spend and support and recommend a systematic means of accounting and reporting.
- To produce an up-to-date report on biodiversity expenditure in the UK.

2. Biodiversity indicators beyond 2010

We began a discussion on what indicators should be developed for use after the 2010 target of halting the loss in biodiversity and this stimulated the dissemination of DEFRAs useful list of current indicators, **Biodiversity Indicators in Your Pocket**

2007. Following discussions with LINK members we were keen to see a greater emphasis on marine landscape ecological quality indicators. The DEFRA booklet describes the marine trophic index and the habitat connectivity index which are under development, with no data available yet. We intend to keep monitoring and encouraging developments in this area.

3. Parliamentary Seminar

The IUCN UK Committee organised a Parliamentary seminar for the All Party Group on Wildlife and Conservation at the end of April in the House of Commons aimed at raising the profile of the 2010 campaign and starting the planning for 2010 onwards.

LINK Membership

The associate membership category ceased in April 2008 and the Scottish Seabird Centre and RZSS have withdrawn. The Soil Association have demitted membership for this year with the intention of renewing their LINK membership next year. The Bumble Bee Conservation Trust (BBCT) have applied for membership and the LINK Board will email their recommendations to members soon.
