#### LINK News

## Chief Officer, Jen Anderson

For staff this is the reporting time for accounts, OSCR, annual stakeholder evaluation, and for our key funders.

**Board:** the Board approved the Budget Outturn and the revised Budget for 2009-10 at their meeting on 24 April. A spreadsheet template for carbon accounting is being prepared and will be circulated to members for their own use.

**Networking Meeting, 24 April:** Notes will be circulated shortly. Discussions on taskforce engagement and the possibility of forming a 'sustainable land use' taskforce or forum of which the current woodlands taskforce would be a subgroup.

**National Conversation:** an internal LINK meeting is being organised so that we can give comments to the Scottish Government (John Mason and Gabby Pieraccini) who are keen to have our input. Please email **Jen** your comments.

**RSE Proposed Inquiry:** following an invitation from Professor David Sugden in March 2009, LINK Board have agreed to provide some modest financial support (£500) to the proposed RSE Inquiry into the implications of climate change and the challenges of public acceptance of climate change policies and the institutional structures needed to deliver them.

LINK Operating Plan 2009-10: This has now been approved by the Board. SOAs: At the subgroup meeting on 19 March, it was agreed that whilst it is important to track local outcomes, currently there are low resources in LINK or member organisations to do this, and instead LINK would prepare a general statement for local authorities giving our main asks, along the lines of those for manifestoes. LINK will ask main reps for their ideal indicators and targets and bring these together for the statement. A SOAs steering group is being formed. Also, SOAs will be on the agenda of the next LINK quarterly ministerial meeting in the autumn. AGM: Preparation is underway for the AGM, Board Meeting and Networking Meeting in Perth on 25 June. John Mayhew will be stepping down as chair and Ian McCall (RAS) has been nominated as his replacement. Deborah Long will continue as vice-chair and David Downie will continue as treasurer, although a replacement is being sought for this role.

**Annual Congress:** 19-20 November, possibly Perth or other central belt venue. A theme of environment and economics, potentially with a link to wellbeing is being developed. A congress steering group is currently being formed.

**Climate communications:** This subgroup are planning to meet to agree the broad messages for all LINK members.

**Legislation**: Very busy period - see our summary of the **current progress of legislation**.

**European Election hustings:** The European Parliament elections are on 4 June. LINK are organising a hustings event on 20 May, 7pm at the St Augustine's church on George IV Bridge in Edinburgh, with a panel of five answering questions from the audience. Details will be emailed to members when arrangements are more final.

**SEW2010:** The steering group met on 29 April, agreed a broad theme of 'Scotland's environment - its great', the aim of 'lobbying light', and preparatory work has now begun. It is hoped that various site visits can be arranged for the spring and summer 2010 so that MSPs can see and take part in members' work. Events in parliament would be subject or 'team' based rather than taskforce based, and would be tailored to more closely match funders' needs.

**Political Strategy Report:** Prepared with input from the Parliamentary Forum and approved by the LINK Board and network at their meeting on 24 April. Some members have taken the report to their own executive boards and some have sent it to their UK colleagues to keep them informed of whats happening in Scotland. Both uses are welcome but remember that the report is limited circulation to the LINK network.

The report will be produced every six months, and the next issue in September will look at how LINK relates to the EU. The following one will look at how LINK relates to local authorities, in particular with less single party council, the role of party manifestoes in influencing local politics and local priorities and performance.

Party Conferences: LINK staff and one member attended the SNP Spring party conference in mid-April. Useful contacts were made and the marine frinege event was successful. We will be attending the Tory conference in Perth on 14-15 May.

# **Publications Received**

An Outline of the Case for a Green Stimulus

Prepared by the researchers from the Grantham Research Institute on Climate Change and the Environment and the Centre for Climate Economics and Policy who also prepared the Stern report.



The report examines the economic case for both fiscal stimulus packages and 'green' expenditure. Specific measures and investments

are assessed, on a scale from 1-3, in terms of timeliness, long-term social return, positive lock-in effects, domestic multiplier and job creation, targeting areas with slack, and timelimitedness and reversibility.

# **European Union Biodiversity Action Plan**

This 2008 report summarises the ten principal objectives over four policy areas and gives examples.
